The Yitro Leadership Program requires my participation, as outlined below:

- (1) Participation in five (5) in-person sessions between April, 2018 and September, 2019, in the camping off-season. I will not miss a session without prior notice and approval of the Yitro IV Program Manager. Exceptions to this stipulation can be made at the discretion of the Yitro IV Program Manager.
- (2) Participation on a site visit to another Jewish camp, during the summer, 2019 camp season
- (3) Work between sessions with Yitro Faculty, work on program development or other assignments, and participate in periodic distance learning opportunities
- (4) Implement at least one project related to Jewish cultural enhancement or expansion at camp
- (5) Support the implementation of the Staff Satisfaction Insight (SSI) survey at my camp in summer 2018 and summer 2019. SSI is an assessment tool that evaluates the summer staff's experience and satisfaction at camp. My camp will be responsible for covering 50% of the cost of this tool each summer, and FJC will cover the remaining 50%.
- (6) Contribute (camp contribution) \$1,000 a year (\$2,000 total) to FJC for my participation in this program, if I am accepted.
- (7) Use Yitro IV program funds toward my own Jewish learning. These funds may be used for immersive Jewish learning experiences or individualized learning. Prior to the use of these funds, I agree to obtain approval from a member of the FJC team. I understand that if I do not utilize these funds by the end of December, 2019, I will no longer be eligible for them.

September 23-25, 2019	Session V <i>Directors attend for a portion and for celebration</i>

If, during the course of the program, my camp's needs have changed and/or I am no longer a full-time employee of my camp, I will contact FJC prior to making those changes. FJC has the right under these circumstances to terminate my participation in Yitro IV. I understand that my camp's participation in a Foundation for Jewish Camp (FJC) Program offers an opportunity to increase community awareness and support of the work that is being conducted by both my camp and FJC. If accepted, I understand that I may be asked by FJC to present the outcomes of the Fellowship to other camp professionals. Materials developed in association with the Fellowship may be shared with the larger camping community on the FJC website or in other formats.
