- **Attend**
 - o Orientation (virtual) - Wednesday, May 15 2-4 PM ET
 - o Seminar 1 - September 23-26, 2024
 - o Seminar 2 (Israel) - February 3-10, 2025
 - o Seminar 3 - April 1-3, 2025
 - o Seminar 4 - October 21-23, 2025
 - o Seminar 5 - January 13-15, 2026

All seminars will be in person unless otherwise noted.

- **Meet** virtually for 1:1 coaching with assigned faculty advisor between each seminar.
- **Engage** in one virtual Mussar Learning workshop between each seminar.
- **Host** a visit from assigned faculty advisor at camp during the summers of 2024 and 2025.
- **Participate** in a site visit to another Jewish camp during the summer of 2025.
- **Support** the implementation of the Camper Satisfaction Insight (CSI) and Staff Satisfaction Insight (SSI) survey at camp in summers 2024 and 2025.

CAMP DIRECTOR COMMITMENTS:

Camp Directors are expected to:

- **Attend** the first hour of the virtual orientation - Wednesday, May 15, 2024, 2-3 PM ET.
- **Participate** in Seminar 5 - January 13-15, 2026.
- **Support** the implementation of key lessons, skills, and insights from the Yitro Leadership Program.

CAMP FINANCIAL COMMITMENTS:

Camps must:

- Sponsor Fellow's participation in the Yitro Leadership Program with a **\$2,000 program fee**.
- Cover the cost of Fellow's **roundtrip airfare and incidentals for the Israel seminar**.
Foundation for Jewish Camp will cover all other seminar costs, including ground travel, room, and board with the exception for 1-2 meals on their own.
- Purchase and disseminate the **Camper Satisfaction Insight (CSI) and Staff Satisfaction Insight (SSI) survey** at camp in summers 2024 and 2025.

Updates to Participation:

If, at any point during the Yitro Leadership Program, circumstances change for either the Fellow or the camp in any of the below ways, the Fellow is responsible for promptly contacting the Yitro Program Director to discuss next steps:

- The Fellow is no longer a full-time employee of the camp.
- The Fellow’s title and/or job description has changed.
- The Fellow’s camp’s needs have changed.
