



COVID-19 Health & Safety Protocols Cornerstone Fellowship 2024

The health and safety of all Cornerstone attendees is Foundation for Jewish Camp's top priority. In addition to hosting a meaningful, safe, and fun Cornerstone experience, it is also FJC's aim to ensure that all participants can safely arrive at their own camps of employment for the summer, on time, as planned. **The Cornerstone Seminar is right before many camps start their staff training. To help you and fellow participants avoid COVID and be on time for their staff training please follow our guidelines below.**

The Cornerstone seminar is planned in coordination with the policies and procedures established by the US Center for Disease Control (CDC), state and local governments, and best practices in the camping field. We are constantly monitoring the situation and as such, these plans are subject to change at any time.

In addition to the policies below, we ask any participants who are not feeling well not to travel to the seminar.

Vaccination Requirements

1. **All participants must have completed their primary vaccine series** for COVID-19 by the Pfizer, Moderna, AstraZeneca, or Johnson & Johnson vaccines.
2. Participant's must attest that they received an initial COVID-19 vaccination, in the Cornerstone registration form prior to their arrival to the seminar.

Before the Seminar

To help with the mitigation of spreading COVID-19, please be mindful of your exposures 5 days prior to arriving at Cornerstone. This includes:

- Masking indoors when with large crowds
- Avoiding spending time with people who you know are sick
- Masking while traveling to Cornerstone (this includes on your flight/in the airport, on your train/in the train station, and/or on a Cornerstone arranged bus)

Pre-Seminar Testing

All Cornerstone participants must test for COVID-19 TWICE prior to their arrival at Cornerstone:

- Test #1: Take an at home rapid test **24 hours prior** to your arrival at the seminar and provide picture proof of a negative COVID-19 test result via a provided form.
- Test #2: ALSO take an at home rapid test **prior to departing home on the day you travel to the seminar** and provide picture proof of a negative COVID-19 test result via a provided form.

→ You will not be permitted to board a Cornerstone bus or to enter the camp property unless you complete this form with results from BOTH tests.

When to test based on your participant type:

Role Types	Test #1	Test #2
Fellows & Senior Fellows, & Supervisors	Saturday, May 18th	Morning of Sunday, May 19th
Leads & Guests	Monday, May 20th	Morning of Tuesday, May 21st

If you test positive for COVID-19 within the 7 days prior to the Cornerstone Seminar, you will not be allowed to attend. The cancellation fee will be waived in this situation.

You are responsible for obtaining and paying for your rapid at home tests used prior to the seminar.

At the Seminar

Testing during the Seminar

All Cornerstone participants must test for COVID-19 the day after they arrive at the Cornerstone seminar. All Fellows, Senior Fellows, and Supervisors will test Monday morning, May 20th prior to arriving to breakfast with rapid tests provided by FJC. Leads and Guests will test Wednesday morning, May 22nd prior to arriving to breakfast with rapid tests provided by FJC.

During the remainder of the seminar, FJC will have additional rapid tests available for any participant who show symptoms of COVID-19.

If you feel sick

There will be a trained nurse on site throughout the duration of the seminar. If you experience COVID-19 symptoms while at Cornerstone, you will receive an onsite rapid antigen test provided by FJC.

1. **Negative Test Result:** If the results of the rapid antigen test come back negative, you will receive appropriate medical care and may be assigned new sleeping arrangements.
2. **Positive Test Result:** If the result of the rapid antigen test comes back positive, you will be quarantined, offered medical care, and provided a second rapid test to check for a false positive.
 - a. If the second test results are negative, you will be asked to wear a face mask in all public settings for the next 24-hour period and may be assigned new sleeping arrangements.
 - b. **If the second test's results are positive, and you live within driving distance of the seminar, FJC requires that you be picked up within 24 hours.**
 - c. If the second test results are positive, and you require a flight home, you will remain quarantined at camp until the conclusion of the seminar. Arrangements will be made for travelling home, or for hotel accommodation (covered by FJC) until you can travel safely.

- d. Any other participants that you have come in close contact with (i.e. those sharing sleeping accommodations dining hall tables, or small group programs), will be informed, monitored, provided with a COVID-19 test as needed, and encouraged to mask indoors.

Mask Policy

Masking is optional during the seminar. We encourage participants to wear masks during large indoor gatherings and will inform participants if we learn of reasons to mandate masking during the seminar. Please be respectful of others' choices regarding masking.

Housing

- Fellows will be housed in camp cabins typically with 3-6 other participants. Cabins include a bathroom with showers, electricity, ceiling fans, and bunkbeds. Senior Fellows will be housed in dorm style housing in the Leadership Center in similarly sized small groups. Other participants are housed in the Leadership Center or retreat-style rooms typically with 0-2 additional participants.
- All facilities will be fully cleaned prior to your arrival. Additional cleaning and disinfection supplies will be on hand for use as desired.

Other Notes

- There will be an option for participants to eat their meals and snacks outside if preferred.
- Water, to fill your water bottles throughout the day, will be provided daily.
- All public areas will be cleaned and sanitized multiple times throughout the day.
- Hand sanitizer will be available throughout the campus.

After the Seminar
